General Release from Liability and Assumption of Risk

RELEASE FROM LIABILITY AND PROMISE NOT TO SUE: In consideration of the Newcomers' Club allowing me to participate in any Newcomers' Club activities, both indoor and outdoor, I hereby release and discharge the Newcomers' Club, its board members, officers, agents, representatives and its activity leaders and/or organizers and hosts/hostesses from any and all claims, present and future, whether known or unknown, from liability for any property damage, personal injury or death sustained by me as a result of my participation in any Newcomers' Club activity. I promise and agree that I will not bring any suit or claim against the Newcomers' Club, its board members, officers, agents, representatives and/or its activity leaders and/or organizers or its activity hosts/hostesses for any property damage, personal injury or death sustained by me as a result of my participation in any Newcomers' Club activity.

ASSUMPTION OF RISK: I am aware that some Newcomers' Club activities involve risks that could result in injury, illness, death and/or loss of or damage to property. I understand that it is my responsibility to evaluate on my own the risk and difficulty of any Newcomers' Club activity and to decide whether I am prepared by having the requisite experience, skill, knowledge, equipment and physical and emotional stamina to participate safely. Any claim for personal injury, death and/or property damage which arises prior to the effective date of such termination shall be subject to this General Release and Assumption of Risk.
